Recently some miscreants have created fake email ids in my name and the same are also furnished here below:

acharyavedvyasa46@gmail.com (letter 'a' is missing after letter 'd' in this fake id)

2) mygvoice1671@gmail.com (This fake I'd is completely different but is being used with my name as K.V. Acharya being prefixed to it)

I was informed by some office bearers of AIBPARC from different places that they have received emails purportedly sent by me to them seeking urgent help as soon as possible. But I did not send any such mail to anybody seeking urgent help. A scrutiny of the email ids revealed the discrepancies in the mail ids as explained above. I am attaching the files of some such mails received from miscreants and forwarded by the recipients to me.

I request you to cause an investigation into the matter and oblige.

Please also advise me as to what precautionary measures should be taken by me to guard my interests and so also that of my friends.
